The Kaiwi Coast Run & Walk is a community oriented journey along the famous Kaiwi Coast scenic highway! The event begins at 6:45 a.m. with sunrise over the Kaiwi Channel, a Hawaiian oli (chant) and the blowing of the pu (conch shell horn). The course starts at Awawamalu (known as Sandy Beach), continues around the Kaiwi coastline, passing Halona and Hanauma Bay, and finishes at the Hui Nalu Canoe Club on the shores of Maunalua Bay.

Participants receive a souvenir miniature glass fishing float and an event t-shirt. T-Shirt size not guaranteed. Shuttle service provided from the Hawaii Kai Park & Ride to the start line, 4:45-5:45 a.m.
